## 2025 EXHIBITOR APPLICATION AND AGREEMENT

This Agreement is between St. George Greek Orthodox Church (hereinafter Church) and (hereinafter Exhibitor).

- Church will provide a 10' x 10' Exhibitor area which includes one 8' table for Exhibitor. If additional tables are needed the fee is \$10 per additional table. There is a limited number of Exhibitor spaces available and applications will be considered on a first come, first serve basis. Cost for 3 days is \$500.00.
- Applications will not be processed without the accompanying full \$100 deposit and full disclosure as to the items/services to be exhibited. All final payments must be received by Saturday, May 24, 2025. A \$35 fee will be charged for all returned checks.
- No cancellations or refunds of any kind will be considered. All Exhibitors are expected to participate all hours during Festival. Booths must be manned at all times and all activity MUST be maintained with your booth.
- Each Exhibitor is allowed 1 assistant. The Exhibitor and their assistant are permitted free admission to the Festival. All other individuals are considered paid guests.
- No sales of any goods are permitted without prior approval from the Church and the Festival Committee.
- Each Exhibitor is required to have their own insurance with St. George Greek Orthodox Church as an additional insured party. Proof of insurance may be requested prior to the Festival.
- The Church is not responsible for any lost, stolen or damaged property of the Exhibitor.
- Set-up must be done on Thursday, May 29, 2025 between the hours of 9 am and 9 pm and Friday, May 30, 2025 between the hours of 9 am and 1 pm. Exhibitors must dismantle their area on Sunday, June 1, 2025 between the hours of 8 pm and 10 pm.
- One Exhibitor parking pass \*will be issued day of set-up\* and must be displayed at all times during set-up and break-down. Parking for Exhibitor will be in designated areas only.

I have read and will comply with the rules of this event. I understand that failure to abide by these rules will result in removal of the Exhibitor from the Festival and all fees will be forfeited.
